

DIRECTIONS TO WALNUT STREET GARAGE/Strawberry Square Complex

From PA Turnpike – Harrisburg East Exchange (#247)

After exiting Turnpike, drive straight ahead on Rt. 283 and get into the left lane. Follow signs to 581 and Harrisburg. Drive about 4 miles and exit at the 2nd Street exit. At the 4th traffic light, you will see the Hilton Hotel on your right. Turn right onto Market Street and immediately go into the left lane. Take the first left into the alley. Go to the end of the block and up the garage entrance ramp. The hotel is accessible from the Strawberry level.

From PA Turnpike – Harrisburg West Exchange (#242)

After exiting Turnpike, take Rt. 83 North to Harrisburg. After crossing the Susquehanna, immediately get off at Exit #43, State Capitol/2nd Street. Follow directions from above.

From Route 15

Cross Susquehanna River on M. Harvey Taylor Bridge into Harrisburg and exit at the Front Street exit. Proceed south to Market Street and turn left onto Market Street. At the first light, the Hilton will be on your left. Pass the Hilton Hotel and turn left into the alley behind the hotel. Go to the end of the block and straight through the stop sign. At the end of the block go up the garage entrance ramp. The hotel is accessible from the Strawberry level.



DIRECTIONS FROM WALNUT STREET GARAGE TO CAPITOL BUILDING

Park your car in the Walnut Street Garage and take your ticket with you for validation. Take the elevator to the Strawberry Square level. Follow the signs for Strawberry Square when getting off of the elevator.

Go up the stairs in front of you and turn left. Walk the walkway to the Food Court level. Cross the food court. There is a covered bridge that will take you through the park and to the Capitol building. For security purposes you will have to enter the capitol at the entrance that faces Third Street – the entrance has a revolving door.

When you go into the capitol rotunda walk behind the staircase and through to the East Wing. Go down the escalator and the breakfast is in the room at the foot of the escalator.

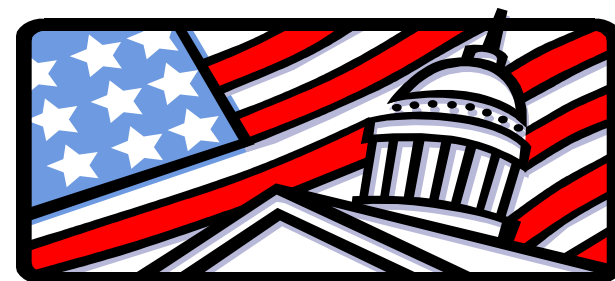

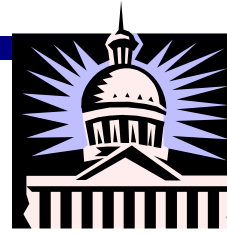
